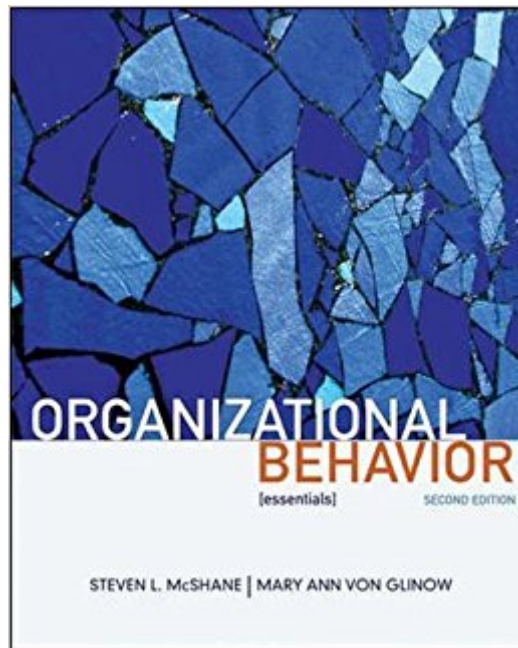

## Synopsis

Steve has published several dozen articles and conference papers on workplace values, training transfer, organizational learning, exit-voice-loyalty, employee socialization, wrongful dismissal, media bias in business magazines, and diverse topics. Steve enjoys spending his leisure time swimming, body board surfing, canoeing, skiing, and traveling with his wife and two daughters.

I liked this textbook because it was easy to understand. There were a lot of good examples and the language was very straight forward, it wasn't filled with technical terms (unless they were defined). I think that it was overpriced, especially for the Kindle version. I bought the hardback so that I could recoup some of my costs at the end of the semester but I would have preferred a cheaper Kindle version to begin with.

It is the book assigned by the instructor, so it is fine in that regard. I would prefer to have the notebook style of textbook, so I don't have to carry around a bunch of heavy books for my classes. Loose leaf notebook also makes it easier to read a chapter at a time, instead of fighting with a book that keeps closing itself.

The book was slightly used but in very good shape. Considering the full price of this book I received it for less than 50% off the original price. The item arrived in the allotted time within the shipment window. I only wish it came a few days sooner. It took about five to six business days and I had a lot of catch up reading to do. With the exception of the beginning chapters, all the others are short and to the point. This book really covers all the aspects of organizational behavior. I would definitely recommend anyone who cannot afford to pay full price to go through to get their books. I would only recommend they order them at least one to two weeks before the semester begins.
